## **Save the date for nutritionDay 2014: 6<sup>th</sup> November 2014**

### **Automatization of nutritionDay in nursing homes and nD oncology:**

From November 2013 our new automation – tool will be ready to use for all participants in nutritionDay in nursing homes and oncology nutritionDay! With this innovation your reports can be downloaded once your data has been completely entered into [www.nutritionday.org](http://www.nutritionday.org).

### **nutritionDay certificates for non-ICU hospital wards and nursing homes**

Certificates will be provided for all non-ICU hospital units and nursing homes which reach the defined participation limits. Make sure you reach the required limits for your units!

1. Minimum of 8 patients/residents have to be included in the audit per unit (this is also the minimum number required to receive a unit report)
2. Minimum of 60% of all patients/residents present on nD have to be included in the nD audit.
3. Minimum of 80% of patients/residents (which have participated on nutritionDay) have to be included in the outcome evaluation 30/180 days after nD.
